KNOW ALL MEN BY THESE PRESENTS, That I, W.J.RAINE, of the County of Eureka, State of Nevada, the party of the first part, for and in consideration of the sum of ONE THOUSAND TWO HUNDRED FIFTY (\$1,250.00) DOLLARS, current lawful money of the United States of America, to me in hand paid by C.H.RAND, of the County of Eureka, State of Nevada, the party of the second part, the receipt whereof is hereby acknowledged, do by these presents, sell unto the said party of the second part, his executors, administrators and assigns, all horses branded with Plug Hat iron on left thigh and belonging to me, save and except those certain horses bearing said iron and known as and called: Bob, Coly, Snip, Fox and Dolly, which said horses so named are hereby reserved and excluded from this sale, and all mules bearing said iron are also reserved and excluded from this sale. I also sell, to said second party, all horses branded 4T on left shoulder and now belonging to me, save and except those certain horses bearing said iron and known as and called: Buck, Nig, a certain Palomena mare and two colts, also six fillies, and I also reserve and exclude from said sale, all mules bearing said 4T brand. There is also reserved and excluded from this sale a certain black saddle horse named Comanche. With this sale made to the party of the second part, are included both of said irons, the Plug Hat iron and the 4T iron, and the exclusive right to the party of the second part to use said irons. The number of horses hereby sold and transferred is not stated but it is the intention of the party of the first part herein to sell and transfer and he does hereby sell and transfer to the said party of the second part, all horses bearing either of said irons, save and except such horses as are specifically reserved.

And I do for my self, my heirs, executors and administrators, covenant and agree, to and with the said party of the second part, his executors, administrators and assigns, to warrant and defend the sale of the said property, goods and chattels, unto the said party of the second part, his executors, administrators and assigns, against all and every person and persons whomsoever lawfully claiming or to claim the same.
