This cause came on regularly for trial in open court on the 17th day of June, 1930, on written stipulation of the parties thereto setting the same for hearing at that time and waiving jury trial, plaintiff appearing by Charles B. Henderson, Esq., it's attorney, and defendant appearing by Morley Griswold and Milton J.Reinhart, her attorneys; evidence both documentary and oral was introduced and the matter was thereupon submitted to the Court for its decision; and it appearing to the Court that all of the allegations of the Complaint on file herein are true and that at the time of filing said Complaint plaintiff filed in the office of the County Record-ers of the Counties of Elko and Eureka, a notice of the pendency of this action, containing the names of the parties, the object of the action and the description of the properties;

And it appearing that the Court has regularly made and filed it's written Findings of Fact and Conclusions of Law herein, in favor of plaintiff and against defendnat and ordering that Judgment be entered accordingly,-

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED;

1. That at all times herein mentioned plaintiff was, and now is, a corporation organized and existing under and by virtue of the laws of the State of California, and registered and licensed and entitled to do business in the State of Nevada.

2. That defendant is the duly appointed, qualified and acting Administratrix of the Estate of Wallace Norman Jameson, also known as Wallace N.Jameson, Deceased.

3. That plaintiff now is, and for a long time hitherto was been, the owner in fee simple and in possession, and entitled to possession, of those certain real properties hereinafter described and it's title thereto is good and valid.

4. That the claim of defendant to said real properties, or any part thereof, is without any right whatsoever, and neither said defendant nor the estate of said Wallace Norman Jameson, also known as Wallace N. Jameson, Deceased, has any estate, right, title or interest whatsoever in or to said land or premises, or any part thereof.

5. That defendant be, and hereby is, forever enjoined and debarred from asserting any claim whatsoever in or to said land or premises, adverse to plaintiff.

6. That the lands and premises herein referred to are all those certain lots, pieces or parcels of land situate, lying and being in the Counties of Elko and Eureka, State of Nevada, described as follows, to-wit:

Northwest Quarter(NW $\frac{1}{4}$ ) of Southwest Quarter (SW $\frac{1}{4}$ ) of Section 9; Northeast Quarter (NE $\frac{1}{4}$ ) of Southwest Quarter (SW $\frac{1}{4}$ ) and North Half (N $\frac{1}{2}$ ) of Southeast Quarter (SE $\frac{1}{4}$ ) of Section 10; Northeast Quarter (NE) of Northeast Quarter (NE $\frac{1}{4}$ ) and South Half (S $\frac{1}{2}$ ) of Northeast Quarter (NE $\frac{1}{4}$ ) of Section 15; and the South Half (S $\frac{1}{2}$ ) of Section 15; all in Township 36 North, Range 51 East, M.D.B. & M., in said Elko County;

Southeast Quarter (SE $\frac{1}{4}$ ) of Southeast Quarter (SE $\frac{1}{4}$ ) of Section 14, Township 35 North, Range 51 East, M.D.B.& M., in said County of Eureka.
