W I T N E S S E T H:

That Grantor, in consideration of the sum of sixty-three thousand four hundred fifteen dollars (\$63,415.) to it paid by Grantee, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, convey, assign, transfer and set over unto Grantee, its successors and assigns, all of Grantor's telephone and telegraph property, both real and personal, situated in the State of Nevada, including all the exchange, toll and farmer lines, telephone and telegraph lines, plant, systems, materials and supplies and the real estate, lands, buildings, easements, rights-of-way, leases, licenses and improvements, and all telephone and telegraph franchises, telephone and telegraph business and the good will of conducting said business, excepting, however, accounts receivable for business done by Grantor up to the date of delivery of this conveyance and cash on hand.

TO HAVE AND TO HOLD the same unto Grantee, its successors and assigns forever.

Grantor empowers Grantee, its successors and assigns, for it and in its name, but at Grantee's own cost, to enforce by suit, action or proceeding of any kind, every right, interest, cause of action, claim or demand hereby assigned, or which Grantor might enforce with reference to any property, contract or right hereby conveyed, in the same manner as if this conveyance had not been made.

And Grantor hereby agrees to execute and deliver all such further conveyances, bill of sale, assignments and other instruments as may reasonable be required to vest the title to any of the property hereinbefore described, or hereby intended to be conveyed, in Grantee, its successors or assigns, or which Grantee may deem desirable as evidence of conveying such title.
