KNOW ALL MEN BY THESE PRESENTS:

For and in consideration of the sum of One Dollar (\$1.00), receipt whereof is hereby acknowledged, the undersigned hereby grants a right of way to Bell Telephone Company of Nevada, a corporation, its successors and assigns, hereinafter referred to as the "Grantee", with the right to construct, place, inspect, maintain and replace thereon poles, crossarms, wires; cables, fixtures, anchors and guys, and to keep the same free from any trees or any parts of trees or any foliage across that certain property situated in the County of Eureka, State of Nevada and described as follows:

The northeast quarter of Section 1, Township 31 North Range 48 East, M.D.B. & M.

Said right of way is a strip of land ten (10) feet in width, five (5) feet on each side of the centerline which is located five (5) feet southerly from and parallel with the northerly line of said described premises.

Said poles are to be located (2) feet southerly from and parallel with the northerly line of said right of way.

The Grantee, its contractors, agents, employees and servants shall at all times have the right of ingress to and egress from said right of way and the poles, crossarms, wires, cables, fixtures, anchors and guys thereon with the specific understanding that the Grantee shall be responsible for an damage suffered by the Grantor caused by the Grantee's exercise of the rights herein granted.

The Grantee is also granted the right from time to time to increase or decrease the size, weight or number and to change the position of the poles, cross arms, wires, cables, fixtures, anchors and guys which may be constructed or installed in or upon the right of way hereby granted.
