RECONVEYANCE AND SATISFACTION.

This reconveyance and satisfaction made and given this 20th day of June, 1930, by F.M. MICHELSON, hereinafter called the "Trustee", to WHITE PINE TELEPHONE COMPANY, a Nevada Corporation, hereinafter called the "Trustor",

W I T N E S S E T H :

WHEREAS, the Trustor did heretofore on or about the 1st day of February, 1910, make, execute and deliver a deed of trust to Salt Lake Security & Trust Company, a corporation, as trustee, to secure the payment of certain bonds of said White Pine Telephone Company, which said deed of trust is recorded in Book 42, pages 441 - 451 of the Mortgage Records of the County of White Pine, State of Nevada, and

WHEREAS, thereafter and on the 31st day of December, 1929, by order of the Third Judicial District Court of the State of Utah, in and for the County of Salt Lake, F.M. Michelson, Trustee, does hereby remise, release and reconvey unto the said White Pine Telephone Company, a Nevada Corporation, its successors and assigns, without any warranty, all the estate and interest derived to him by or through said deed of trust, in all the property, real, personal and mixed, of every kind, nature and description described in said deed of trust, together with the appurtenances thereto, special reference being made to said deed of trust and the record thereof for a more particular description of the said property.

TO HAVE AND TO HOLD the same without any warranty unto the said White Pine Telephone Company, a corporation, and assigns forever.
