DECREE OF SETTLEMENT OF FINAL ACCOUNT AND DISTRIBUTION

Filed June 29, 1931 Ed.Delaney. County Clerk.

Ethel D. Hussey, Executrix of the Last Will and Testament of F.B.Hussey, sometimes known as Fred B. Hussey, and/or Frederick B.Hussey, and/or Frederick Byram Hussey, deceased, having on the 11th day of June, 1931, rendered and filed herein a full account and report of her administration of said estate, which account was for final settlement, and having with said account filed a petition for the final distribution of the estate;

And said account and petition this day coming on regularly to be heard, proof having been made to the satisfaction of the court that the Clerk had given notice of the settlement of said account, and the hearing of said petition in the manner and for the time required by law;

And it appearing that said account is in all respects true and correct; that all claims and debts against said decedent, all taxes on said estate, all debts, expenses and charges of administration have been fully paid and discharged; and that said estate is ready for distribution and in condition to be closed; that said estate is community property; that the said F.B.Hussey died testate, leaving him surviving his widow, Ethel D. Hussey, who by the terms of said will is entitled to receive all the rest, residue, and remainder of said estate, of whatever kind, nature and description, and wherever situate, as hereinafter described, remaining for distribution;

It is ordered, adjudged and decreed, that the said final account of said Ethel D.Hussey as Executrix aforesaid, be, and the same is, fully settled, allowed, and approved, and that the residue of said estate hereinafter particularly described, and any other property not now known or discovered, which may belong to the said estate, or in which the said estate may have any right, title, or interest, and wherever situate, be, and the same is, hereby distributed as follows:

All of said property be distributed to his widow, Ethel D. Hussey.

The following is a particular description of said residue of said estate referred to in this decree and of which distribution is now ordered and decreed as aforesaid:-

All the water and water rights described and referred to in Water Permits Nos. 6312, and 6566 of the State Engineer's Office of the State of Nevada.
