SUBORDINATION AGREEMENT.

WHEREAS, KATE GRIFFIN, a widow, and WILLIAM B. GRIFFIN, JAMES J. GRIFFIN, CHARLES J. GRIFFIN and ALLEN T. GRIFFIN, are indebted to the HENDERSON BANKING COMPANY in the sum of TWENTY-SEVEN THOUSAND FIVE HUNDRED (\$27,500.00) DOLLARS: and

NOW, THEREFORE, in consideration of said Henderson Banking Company making said loan to the said Mortgagors hereinbefore mentioned, and other and sufficient consideration, the undersigned do hereby undertake and agree with said Henderson Banking Company of Elko, Nevada, that all notes secured by said Mortgage, together with all future advances that may be made thereunder shall have priority in right and remedy over any claim or claims, however evidenced, in favor of the undersigned and with specific reference to the specific devises to the undersigned hereinbefore mentioned.
