ORDER AND DECREE SETTLING FINAL ACCOUNT AND FOR DISTRIBUTION.

Comes now DORA E. KAPPLER, the Administrator of the Estate of ERNEST E. KAPPLER, Deceased, and proves to the satisfaction of the Court that her first and final account and petition for distribution herein was rendered and filed on the 6th day of March, 1933; that heretofore upon application of petitioner, the Court made an order that the administration of said estate be summary, it having appeared to said Court that the entire value of said estate did not exceed the sum of Three Thousand (\$3000.00) Dollars;

And said account and petition this day coming on regularly to be heard, and proof having been made to the satisfaction of the Court that the Clerk had given notice of the settlement of said account and the hearing of said petition, in the manner and for the time as required by law; said account and petition being now presented to the Court, and no person appearing to except or contest said account or petition, the Court after hearing the evidence, being satisfied that no taxes are due upon the property of the estate; and it appearing that no claims have been filed against said decedent or said estate, and that all expenses and charges of administration have been fully paid and discharged; that said estate is ready for distribution and in condition to be closed;

That the said estate is community property; and

That the said ERNEST E. KAPPLER died intestate in the County of Elko, State of Nevada, on or about the 9th day of December, 1932, and at the time of his death was a resident of the said County of Elko, State of Nevada, and left as his only heirs, who are entitled to distribution of his estate, the following named persons:

Dora E. Kappler, over the age of twenty-one years, residing at Carlin, Elko County, Nevada, a widow of said deceased.

Beulah Carroll, of the age of thirty, residing at Carlin, Nevada, a daughter of said deceased.

Dorothy Fronberg, age twenty-nine years, residing at Stockton, California, a daughter of said deceased.

That all of the residue of the property of said estate of which decedent died possessed is particularly described as follows, to-wit:

Cash on deposit in United States Postal Savings . . . . .	\$1500.00
Cash on deposit in open account in First National Bank of Elko, Nevada. . . . .	655.94
Cash on deposit in Henderson Banking Company of Elko, Nevada, which bank is now in the hands of the State Bank Examiner, and which funds are impounded and not available to said estate . . . . .	491.83

An undivided one-half interest in and to the following named unpatented mining claims in Lynn Mining District, Eureka County, Nevada, being the Hilltop, Hilltop No.1, Hilltop No.2, Hilltop Fraction and Hilltop Fraction No.1.

One second-half automobile.

IT IS HEREBY ADJUDGED AND DECREED, that due and legal notice to creditors has been given in the manner and for the time required by law and that the affidavit of the publication of the notice to creditors has heretofore been filed with the Clerk of the above-entitled Court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, that the final account of the said administratrix be, and the same is hereby, settled, allowed and approved and that the residue of said estate above particularly described, and any other property, real or personal which may belong to said estate, or in which the said estate may have any interest, be, and the same is hereby distributed as follows:

An undivided one-half ( $\frac{1}{2}$ ) thereof to Dora E. Kappler, widow of said deceased, residing at Carlin, Nevada.

An undivided one-fourth ( $\frac{1}{4}$ ) thereof to Beulah Carroll, a daughter of said deceased, residing at Carlin, Nevada.

An undivided one-fourth ( $\frac{1}{4}$ ) thereof to Dorothy Fronberg, a daughter of said deceased, residing at Stockton, California.

It further appearing to the Court that the sum of Fifteen Hundred (\$1500.00) Dollars belonging to said estate, and above referred to, is on deposit in United States Postal Savings at Elko, Nevada, and

IT IS FURTHER HEREBY ORDERED, ADJUDGED AND DECREED, that the said United States Postal Savings deposit in the name of Ernest E. Kappler, now deceased, be paid to said administratrix, and said administratrix is ordered and directed to pay and distribute said sum as above ordered.
