DECREE OF DISTRIBUTION AND ORDER SETTLING FINAL ACCOUNT AND REPORT.

Andrew C. Dibble, administrator of the state of Fred B. Crofut deceased having on the 21st day of December, 1932 rendered and filed herein a full account and report of his administration of said estate which account is for final settlement, and having with his said account filed a petition for distribution of said estate, and said account and petition for distribution coming on regularly for hearing, and proof having been made to the satisfaction of the court that the clerk had given notice of the hearing of said account and petitioner distribution in the manner and for the time required by law, and it appearing that notice to creditors has been duly given according to law. It appearing that said account is in all respects true and correct, and that it is supported by proper voucher and that the residue of said estate in the hands of the administrator at the time of filing said account and report is the sum of \$77.53, and that the sole heir, Emma E. Dibble has advanced money to pay all of the claims and expenses of administration, and that the sums so paid by the administrator were necessarily expended in the course of administration of said estate, the vouchers whereof are now filed herein and the said account and report is now settled and allowed and approved. That all of the claims against said estate and the expenses of administration have been fully paid and discharged, and that the estate is now in a condition to be closed and the residue distributed.

IT IS ORDERED, ADJUDGED, and DECREED THAT NOTICE TO CREDITORS was duly given according to law; that the account and report of the administrator filed herein be approved, allowed, and settled; that the estate is now in a condition to be distributed; that Emma E. Dibble is the sole heir at law, and is entitled to have distributed to her the residue of said estate, and the whole thereof. That the correct name of decedent was Frederick B. Crofut.

WHEREFORE, it is ORDERED, ADJUDGED, AND DECREED that all of the following described property, and any other property not now discovered, or which may hereafter be discovered, belonging to said estate be distributed as follows: To Emma E. Dibble, mother of deceased, the following described property:

South 115 feet by 200 feet of lot 33 in Block 39, of the Town of Eureka, County of Eureka, State of Nevada.

Lots No. 2, 3, and 4, in Block No. 2, of the Town of Eureka, Nevada; Lots eighteen (18) and nineteen (19), in Block twenty-four (24) of the City of Elko, County of Elko, State of Nevada.
