NOTICE OF PENDENCY OF ACTION

NOTICE IS HEREBY GIVEN: That an action has been commenced in the above entitled court by the above named plaintiffs against the above named defendants, for the purpose of restraining and enjoining said defendants, and each of them, from preventing or in any way interfering with plaintiffs going upon certain mining claims and working and developing the same; for the further purpose of securing from said court a determination that a purported cancellation by the defendants Walti and Romano on the 10th day of May, 1934, of a certain agreement executed on the 4th day of November, 1932, by said defendants and recorded in Book of Miscellaneous Records, at page 19 thereof, in the records of the County Recorder of Eureka County, Nevada, and an attempted transfer and conveyance to the defendants Benson and Withnell, by the defendant Walti, and a certain quit claim deed from the defendant Walti to the defendants Benson and Withnell, dated the 10th day of May, 1934, and recorded in Book 21 of Deeds, at page 184 thereof, in the records of the County Recorder of Eureka County, Nevada, are each of them void and of no effect and a cancellation of each of said instruments and said purported cancellation; and for the further purpose of securing from said court a determination that no person other than the defendants Lawn, Nissen, Romano and Keystone Mines, Ltd. have any interest in or to any of said claims; and for the further purpose of being awarded damages by said court, and of obtaining further relief.
