} Right of Way.

KNOW ALL MEN BY THESE PRESENTS:

For and in consideration of the sum of One Dollar (\$1.00), receipt whereof is hereby acknowledged, the undersigned hereby grants a right of way ot BELL TELEPHONE COMPANY OF NEVADA a corporation, its successors and assigns, hereinafter referred to as the "Grantee," with the right to construct, place inspect, maintain and replace thereon poles, cross-arms, wires, cables, fixtures, anchors, guys, underground conduits and manholes, and to keep the same free from any trees or any parts of trees or any foliage across that certain property situated in the County of Eureka, State of Nevada and described as follows:

The South half of the Southwest quarter, the Northeast quarter of the Southwest quarter and the North half of the Southeast quarter ( $S\frac{1}{2}$  of  $SW\frac{1}{4}$ ,  $NE\frac{1}{4}$  of  $SW\frac{1}{4}$  and  $N\frac{1}{2}$  of  $SE\frac{1}{4}$ ) of Section 32, and the Northwest quarter of the Southwest quarter and the Southwest quarter of the Northwest quarter ( $NW\frac{1}{4}$  of  $SW\frac{1}{4}$  and  $SW\frac{1}{4}$  of  $NW\frac{1}{4}$ ) of Section 33, all in Township 32 North, Range 49 East, M.D. B.&M.

Said right of way is a strip of land ten (10) feet in width, five (5) feet on each side of the center line of the pole line as now located on said described property except at those locations where it is necessary to construct, locate and install guys with anchorage, then said right of way is to include said guys and anchors which are not to be constructed beyond a maximum distance of twenty-five (25) feet from said centerline.

It is understood and agreed that the abandonment of Grantee's facilities upon said right of way or the complete removal of grantee's facilities therefrom shall constitute an abandonment of the said right of way, whereupon title to said right of way shall immediately revert to and revest in Grantor herein, its successors or assigns. Non-user of Grantee's facilities upon said right of way for a continuous period of two (2) years shall constitute an abandonment within the meaning of foregoing provisions.

The Grantee, its contractors, agents, employees and servants shall at all times have the right of ingress to and egress from said right of way and the poles, cross-arms, wires, cables, fixtures, anchors, guys, underground conduits and manholes thereon with the specific understanding that the Grantee shall be responsilbe for any damage suffered by the Grantor caused by the Grantee's exercise of the rights herein granted.

The Grantee is also granted the right from time to time to increase or decrease the size, weight or number and to change the position of the poles, cross-arms, wires, cables, fixtures, anchors, guys, underground conduits and mahholes which may be constructed or installed in or upon the right of way hereby granted.

IN WITNESS WHEREOF, the undersigned has executed this grant this 2nd day of August, 1934.
