NOTICE OF RESIGNATION OF WILLARD D. ELLIS AND CHAS. PARKER AS TRUSTEES AND THE APPOINTMENT OF FRANK R. HODGSON AND H.W.BROWNING AS TRUSTEES IN FEDERAL LAND BANK OF BERKELEY LOANS.

## TO WHOM IT MAY CONCERN:

Notice is hereby given that the Board of Directors of THE FEDERAL LAND BANK OF BERKELEY, a corporation, has accepted the resignations of WILLARD D. ELLIS and CHAS. PARKER as Trustees and has appointed FRANK R. HCDGSON and H.W. BROWNING as successors to WILLARD D. ELLIS and CHAS.

PARKER in those various deeds of trust hereinafter more fully described, said appointment having been made by resolution of the Board of Lirectors of said Bank, of which the following is a true and correct copy, to-wit:

"BE IT FURTHER RESCLVED that said appointment is subject to all the rights, privileges, powers and prerogatives which said deeds of trust have conferred upon The Federal Land Bank of Berkeley as Beneficiary therein."
