FARL CREDIT ADMINISTRATION SUBCRDINATION AGREEMENT

KNOW ALL MEN BY THESE PRESENTS: THAT, WHEREAS, Cadet Anxo and Mary Anxo, (hereinafter referred to as the "Borrower") has applied to NevadaLivestock PRODUCTION CREDIT ASSOCIATION of Reno, Nevada, (hereinafter for convenience referred to as the "Credit Association"), for a loan to be made to the Borrower and to be evidenced by a promissory note or notes secured by a crop and chattel mortgage covering certain personal property; and

AHERIAI, the said personal property so offered by the Borrower as security to the Credit association is presently subject to the prior lien of that certain chattel mortgage hereinafter in paragraph (a) hereof more particularly described; and

THEREAS, the Credit Association will make the said loan or extend credit to the Borrower only upon the condition precedent that the chattel mortgage hereinafter more particularly described in paragraph (a) hereof be subordinated to the lien of the crop and chattel mortgage to be given by the Borrower to the Credit Association and hereinafter more particularly described in paragraph (b) hereof:

MOW. THEREFORE, in consideration of the premises and the making of the said loan, and/or the extension of credit by the said Credit Association to the said Borrower, the undersigned does hereby agree that:

- (a) That certain chattel mortgage covering 5300 ewes, 1400 ewe lambs and 100 bucks and made and given on the 30th. day of December 1933, by Cadet Anxo and Mary Anxo to Far. & Mer. Natl. Bank, Eureka, Nev. and recorded on the 13th. day of January 1934, at page 406 et seq., of Vol. A of Real and Chattel Mortgages Records of Eureka County, State of Nevada. be and the same is hereby subordinated and made subject and subsequent to the lien of:
- (b) That certain crop and chattel mortgage covering 4990 ewes, 3745 lambs, 100 bucks, mules burros, horse and livestock feeds, and made and given on the 1st day of August, 1935, by CADET ANKO, and MARY ANKO, his wife, to HevadaLivestock Production Credit Association, and filed on the 15th day of Lugust 1935, Records of Eureka County, State of Nevada.

The undersigned does hereby agree that the filling in of any and all blanks contained in paragraphs (a) and (b) of this agreement, after the execution hereof by the undersigned, shall not be deemed an alteration hereof, and the undersigned does hereby authorize the Credit Association or the Borrower, as its attorney in fact, to fill in the said blank spaces, and does hereby authorize the Borrower and/or the Credit Association to record this Subordination Agreement.

The undersigned hereby certifies that he or it is the owner of the evidence of indebtedness or lien or title creating instrument hereby subordinated, and that the same is or are in his or its possession, and that the same or any interest therein, will not be transferred without first procuring the written consent of the Credit Association.
