That he is a resident of the City of Elko, County of Elko, State of Nevada, and has been a resident thereof for a great number of years last past;

That he was acquainted with F.L. ENGSTROM who was named as Grantee in a deed from John Hovenden, dated March 22, 1902, recorded March 27, 1902 in Book 14 of Deeds, page 418; that on September 24, 1902 FRANK ENGSTROM conveyed said lands to MRS. MARY McCONNELL, said deed being recorded January 28, 1903 in Book 14 of Deeds, page 492; the lands hereinbefore referred to being being SE $\frac{1}{4}$ of NW $\frac{1}{4}$; SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 6, in Township 31 North, Range 49 East, M.D.B. & M.,; that said F.L.ENGSTROM named as Grantee above, and FRANK ENGSTROM named as Grantor above was one and the same person;

That he was well acquainted with ETHEL W. DEAN and FLORA DEAN MAGEE, who are named as Grantee in a certain deed from DOMINGO AGUILAR and ELLA AGUILAR, dated November 7, 1908, recorded March 24, 1909, in Book 16 of Deeds, page 245, covering the S $\frac{1}{2}$ of SW $\frac{1}{4}$ of Section 4; SE $\frac{1}{4}$ of NW $\frac{1}{4}$; SW $\frac{1}{4}$ of NE $\frac{1}{4}$ and Lots 1, 2, 3, 4 and 5 of Section 6; SE $\frac{1}{4}$ and N $\frac{1}{2}$ of Section 8, in Township 31 North, Range 49 East, M.D.B. & M.,

That thereafter ETHEL W. DEAN married FREDERICK B. HUSSEY and her name became ETHEL D. HUSSEY, and thereafter said FLORA DEAN MAGEE married WALTER HOBART and became FLORA DEAN HOBART: that ETHEL D. HUSSEY, named as Grantor in the Deed to FLORA DEAN HOBART dated March 2nd, 1927, recorded May 4, 1927 in Book 20 of Deeds, page 211, was one and the same person as ETHEL W. DEAN;

That on August 31, 1934, FLORA DEAN HOBART and ETHEL DEAN HUSSEY conveyed said lands to HENDERSON BANKING COMPANY MORTGAGE CORPORATION, which said deed was recorded on the 19th day of November, 1934, in Book 21 of Deeds, page 223;

That FLORA DEAN MAGEE, heretofore mentioned and FLORA DEAN HOBART were and are one and the same person; that ETHEL W. DEAN and ETHEL D. HUSSEY and ETHEL DEAN HUSSEY hereinbefore mentioned were and are one and the same person.

That on the 31st day of August, 1934, both ETHEL DEAN HUSSEY and FLORA DEAN HOBART were widows.
