There was presented to the Board a petition to vacate a portion of Seventh Street of the Town of Beowawe, dated November 13, 1935, by F.J.Smyth. The exact parcel sought to be vacated is hereinafter described in this order. The petition is filed under the provisions of an Act of the Legislature of the State of Nevada, approved March 13, 1905 (Statutes 1905, page 223) entitled "An Act authorizing owners of land to lay out and plat such land into lots, streets, etc." The written consent to the granting of said petition, signed by F.E.Leonard, owner of the lot fronting on the opposite side of the street, and the written consent of Humboldt Land & Cattle Company, owner of the unsold lots in said townsite, were attached to the petition. A plat showing the location of the lots and blocks in Beowawe, having to do with the petition, is also attached as an Exhibit.

Upon due consideration it was, on motion duly made and seconded, unanimously:

RESOLVED: That this Board is satisfied that the facts stated in the said petition are true, and that the petitioner is entitled to the relief requested, and that it has been sufficiently shown to the satisfaction of this Board that neither the public nor any person will be materially injured by the granting of such relief and the vacating of the said portion of Seventh Street; and that the said portion may be lawfully vacated in accordance with said Act, and particularly under the provisions of Section 1351 Nevada Compiled Laws;

RESOLVED FURTHER: That that portion of Seventh Street of the Town of Beowawe, described as follows, is hereby vacated, to-wit:

A parcel of land 25' by approximately 80', being a 25' strip of land lying adjacent and contiguous to the southeasterly boundary of Lot 18 in Block 9 of said Town, more particularly described as follows, commencing at the southerly corner of Lot 18 of said Block 9 and running thence southeasterly along a line parallel to railroad Street, 25'; thence at right angles northeasterly approximately 80' to the southwesterly bank of the Humboldt River; thence at right angles northwesterly 25' to the southeasterly boundary line of said Lot 18; thence at right angles southwesterly approximately 80' to the point of beginning.
