Be it known that the several parties hereto duly appearing herein and stipulating that judgment and decree as herein provided shall be made and entered herein, and the said stipulation having been read and filed and duly considered by the Court:

NOW, IT IS ORDERED, ADJUDGED, AND DECREED that title be and it is hereby quieted J. B. McNaughton in and to those certain unpatented lode mining claims situate in the Eureka Mining District, Eureka County, Nevada named WABASH NO.1, WABASH NO.2, and WABASH NO.3, and amended location certificates of which are of record in the office of the County Recorder of Eureka County, Nevada in Book K of Eureka County Mining Locations at pages 217, 219 and 220 respectively, reference being hereby made to said record for a more particular description of said claims.

AND IT IS FURTHER ORDERED, ADJUDGED AND DECREED that title to all machinery, tools and other mining equipment of a personal property nature now located on said mining claims be and it is hereby reserved from the operation of the foregoing, and adjudged to be in the intervenors J. Arnold Farrer, of Boston, Massachusetts, and John H. Sherburne of the same place, as a Committee of Bondholders of the said Eureka Smelting Company under an agreement dated December 27, 1929.

AND IT IS FURTHER ORDERED, ADJUDGED AND DECREED that each of the parties hereto shall pay its costs in this cause incurred.
