ORDER SETTING APART ESTATE FOR SUPPORT OF
SURVIVING WIFE AND MINOR CHILDREN

The affidavit and petition of INA B. TOGNONI coming on regularly this day to be heard before the above entitled Court and the undersigned Judge thereof, the petitioner appearing by B.L. QUAYLE, Esquire, of the firm of CHANDLER, QUAYLE & GILL, of Ely, Nevada, her attorneys, at the hour of ten o'clock A.M. of said day, and it appearing to the satisfaction of the Court that due and legal notice of the time and place of the hearing of said petition had been given by the Clerk, and no one appearing in opposition thereto;

And it further appearing to the satisfaction of the Court that petitioner is the surviving wife of JOSEPH R. TOGNONI, who died intestate at Eureka, Nevada on February 26, 1936, and was at the time of his death a resident of Eureka County, Nevada, and left estate in said county and in the County of Nye of said State of Nevada, consisting of real and personal property hereinafter described, and that the whole value of said estate in said two counties so left by deceased is such as to render it amendable to this order under the law;

That the items of said property, so far as known to petitioner, are the following:

Real Property

Lots 1 and 2 of Block 82 of the Town of Eureka, with the family home situate thereon, together with sheds and outbuildings.

Seventeen unpatented lode mining claims in Silverton Mining District, Nye County, Nevada, named MANHATTAN NO.1, MANHATTAN NO.2, ELEPHANT NO.1, ELEPHANT NO.2, WOODRAT NO.1, WOODRAT NO.2, WOODRAT NO.3, SILVER QUEEN NO.1, SILVER QUEEN NO.2, SILVER QUEEN NO.3, SILVER QUEEN TUNNEL, SILVER DOLLAR, SILVER DOLLAR NO.2, MAYFLOWER NO.1, MAYFLOWER NO.2, MAYFLOWER NO.3, and MAYFLOWER NO.4, notices of location of which are of record in the office of the County Recorder of said Nye County.

PERSONAL PROPERTY

Old Dodge Touring Car being reconstructed into light truck, year 1926.

Furniture in family home.

Equity in 1934 Chevrolet truck, 1½ ton capacity, under conditional sale contract from Ely Garage, Ely, Nevada.

That the whole of said real and personal property is community property.

That deceased left him surviving beside petitioner, his widow, aged 37, the following minor children: Nye W. Tognoni, a son, aged 18, Neva J. Tognoni, a daughter, aged 16, Hale C. Tognoni, a son, aged 15, and Robert L. Tognoni, a son, aged 12, all of whom reside with petitioner at the family home in Eureka, Nevada.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the whole of said estate, both real and personal, as hereinabove described, be and the same is hereby assigned and set apart for the support of petitioner, Ina B. Tognoni, the surviving wife, and of the above named minor children of said deceased.
