ORDER OF ADOPTION

It being shown to this court, in the above entitled matter, that J.B.BIALE, and LAURA BIALE, his wife, on the 15th day of February, 1937, filed a petition in said court for leave to adopt John Charles Vaccaro, a minor child of Charles Vaccaro, and Clotilda Biale Vaccaro, deceased; that said minor child.
