Approximately 8,000 head of range cattle; Approximately 160 head of horses and mules;

All other livestock of every kind and character;

All farm and ranch buildings, machinery, tools, furnishings and equipment;

All growing and harvested crops, including approximately 7,000 tons of cut and stacked native hay;

Together with the iron ^TS and other brands and marks belonging to the party of the first part;

The above description is meant to and does hereby include all cattle, horses, livestock, machinery, tools, furnishings and equipment, growing and harvested crops and cut and stacked hay, and all other personal property belonging to the party of the first part, whether the same be correctly described herein or at all.

TO HAVE AND TO HOLD the same to the said party of the second part, its successors, and assigns forever.
