KNOW ALL MEN BY THESE PRESENTS: That, WHEREAS, on the 12th day of December, 1936, the under-
signed, HENDERSON BANKING COMPANY MORTGAGE CORPORATION, a Nevada Corporation, entered into an
Escrow Agreement of Sale with THOMAS S. WILSON and JOHN A. SMITH for the sale of certain lands
and personal property, which personal property is hereinafter described; and

WHEREAS, on the 23rd day of December, 1936, said THOMAS S. WILSON and JOHN A. SMITH,
assigned all of their right, title and interest in and to the above mentioned Agreement to CUBA
CONSOLIDATED COMPANY, a Nevada Corporation; and

WHEREAS, CUBA CONSOLIDATED COMPANY on the 16th day of March, 1937, changed its name to
GOLD QUARRY MINES, INC., said Certificate of Change of Name having been filed in the office of
the Secretary of State of the State of Nevada on the 7th day of June, 1937; and

WHEREAS, on the 9th day of November, 1937, said GOLD QUARRY MINES, INC., formerly named
and known as CUBA CONSOLIDATED COMPANY, assigned all of its right, title and interest in and to
said Agreement of December 12th, 1936, hereinbefore mentioned, to DAN FILIPPINI, of the County
of Lander, State of Nevada,

NOW, THEREFORE, THIS INDENTURE WITNESSETH: That said HENDERSON BANKING COMPANY MORTGAGE
CORPORATION, a corporation duly organized and existing under and by virtue of the laws of the
State of Nevada, with principal place of business in the City of Elko, County of Elko, State
of Nevada, the party of the first part, for and in consideration of the sum of TEN (\$10.00)
DOLLARS, lawful money of the United States of America, to it in hand paid by DAN FILIPPINI, of
the County of Lander, State of Nevada, the party of the second part, the receipt whereof is
hereby acknowledged, does by these presents grant, bargain, sell and convey unto the said party
of the second part, his heirs, executors, administrators and assigns forever, all of the follow-
ing described chattels, to-wit:

Approximately 18 head of horses, being all of the horses situated on the real property
this day conveyed to said party of the second part, in Lander and Eureka Counties, State of
Nevada, as of the 12th day of December, 1936; said horses carrying various irons; said Grantor
not being bound at the date hereof as to the numbers.

Together with all farm implements, tools and machinery situated on said above referred to
real property owned by said Grantor, together with the branding iron Half Circle thus:
on the right ribs for cattle; and the branding iron JD thus on the left shoulder for
horses.

It being understood that this conveyance is hereby made of the bare branding irons only,
and not to carry any livestock, save and except the horses that may carry said JD iron above
mentioned and enumerated, as approximately 18 head, more or less.

TO HAVE AND TO HOLD the same to the said party of the second part, his heirs, executors,
administrators and assigns forever.
