## LEASE AND OPTION TO BUY

and by these presents does grant, demise and let to the Lessee all the following described

IT IS FURTHER AGREED by and between the parties hereto that should the Lessee fail to pay the amounts afore mentioned which may hereafter become due in accordance with the terms hereof and such failure shall continue for a period of thirty (30) days after the service of written notice thereof upon the said Lessee by registered mail addressed to it at 836 Gilman Street, City of Berkeley, County of Alameda, State of California, or upon its superintendent, agent or representative on said premises, then the said Lessor shall be released and relieved of and surrender to the said Lessor said mining claims and the property and the right of the said Lessee therein and thereto shall thereupon terminate and cease.
