DECREE OF DISTRIBUTION, AND ORDER ALLOWING
FINAL ACCOUNT.

CORDELIA W. WHITMORE, executrix of the estate of N.A. Whitmore, sometimes known as Norman A. Whitmore, deceased, having on the 5 day of November, 1938 rendered and filed herein a full account and report of her administration of said estate, which said account was for final settlement, and having with said account filed a petition for the final distribution of the estate;

And said account and petition coming on this day regularly to be heard, proof having been made to the satisfaction of the court that the clerk had given notice of the settlement of said account, and hearing of said petition for distribution, in the manner and for the time required by law, and each of the heirs, interested in said estate having signed and acknowledged receipt of notice of the filing of said account and petition for distribution, and each thereof having consented that said account be approved and distribution be made in accordance with said report and petition;

and it appearing that said account and report is correct in all respects, and that it is supported by proper vouchers; that the residue of the money in the hands of the executrix, at the time of filing said account was, \$7,114.42; that the sum of \$324.50 was expended as necessary administration costs, the vouchers whereof, together with a statement of such expenses and disbursements, are now presented and filed, and said statement is now settled and allowed, and the payments are approved by this court; and it appearing that all debts and claims against said decedent, all taxes on said estate, and all debts and expenses of administration have been fully paid and discharged, and that said estate is ready for distribution, and in condition to be closed:

And it further appearing to said court that notice to creditors and of the appointment of the said executrix was duly made as required by law, it is

ORDERED, ADJUDGED, AND DECREED that notice to creditors has been given for the time and in the manner required by law; that the said final account and report of the said executrix be, and the same are, settled, allowed, and approved, and that the residue of said estate hereafter particularly described, and any other property not now known or discovered, which may belong to said estate, or in which the said estate may have any interest, be, and the same is hereby, distributed as follows: To Nevada Whitmore Minola, daughter of said deceased, \$100.00; To Mary Whitmore Taylor, daughter of said deceased, \$100.00 John E. Whitmore, son of said deceased \$100.00; to James P. Whitmore, son of said deceased \$1.00; all of the rest, remainder and residue of said estate of every kind and nature, and wheresoever situated, to Cordelia W. Whitmore, widow of said deceased; consisting of four lots in block E of the town of Palisade, Nevada, and four other lots not otherwise particularly described located in the town of Palisade, Nevada, together with all water rights located thereon known as the Jewell springs the water from which is used on said lots; One store Building; two cellars; one frame dwelling house; Ebert House; Barn located near the Humboldt river, all in the town of Palisade, Nevada, One Delco light plant, One gasoline Pump and storage tank, one wood refrigerator, all furniture contained in the buildings above described, One air compressor unit, and all other articles of every kind and nature, and especially all the articles enumerated in the inventory of said estate now on file herein, and all other property belonging to said estate whether enumerated herein, or in the inventory hereinabove mentioned or not; also the following described shares of corporation stock: Certificate Number C270801 of UNITED STATES STEEL CORPORATION, PREFERRED CAPITAL STOCK, 15 shares, standing in the name of Norman A. Whitmore.

Certificate Number 4044 of Compania Swift International, Capital Stock, 18 shares, standing in the name of Norman A. Whitmore.

Certificate Number C017081 of SWIFT AND COMPANY, Capital Stock, 84 shares, standing in the name of Norman A. Whitmore.

Certificate Number 7124 of SWIFT AND COMPANY, 4 shares.

Certificate Number F7143 of SWIFT AND COMPANY, 1/5 shares.

That the decedent herein most often signed his name "N.A. Whitmore" and that B.A. Whitmore, and Norman W. Whitmore, is one and the same person; that Norman A. Whitmore is the true name of the decedent herein.

Also cash in the sum of \$6,813.42. Also Certificate of stock of the Henderson Banking Company Mortgage Company number 2241 for 9824.45 shares representing a deposit in the defunct Henderson Banking Company of \$10,828.80, on which there remains due 49% of the deposit.
