Ed Delaney, CLERK.AMENDED ORDER SETTLING FINAL ACCOUNT
AND FOR DISTRIBUTION UNDER WILL.

Now comes ANTHONY PARONI, the Administrator with will annexed of said estate, by Howard E. Browne, Attorney, and proves to the satisfaction of the court that his final account and petition for distribution herein was rendered and filed on the 16th day of October, 1937; that a Supplemental Account to the Final Account of Administrator was filed on March 25, 1939; that a Second Supplementary Account to Final Account of Administrator was filed on March 27, 1940; and that the hearing of the said Accounts was duly published in the Eureka Sentinel; that due and legal notice of the time and place of said settlement and hearing has been given as required by law, and that the said accounts and petition are now presented to the court together with the objections thereto; and the said accounts together with objections were presented on May 16th, 1940 and duly considered. The Court has heretofore rendered its decision settling the Final Account and Supplemental Accounts filed thereto and has signed and filed Findings of Facts and Conclusions of Law.

The Final Account and Supplemental Accounts are settled and allowed as rendered with corrections, as set out in the Court's Decision and Findings of Facts and Conclusions of Law.

A part of the assets of said estate consists of a savings account in a Swiss bank, No recent information is available as to the present status of said account. However, it is estimated that said account computed at compound interest at 1% per annum as of June 30, 1940, amounts to \$791.73. It is stipulated between the attorneys for the heirs that should the above figure be in error that the same will be adjusted between them from the returns of the Eureka Water Works.

It is ordered, Adjudged, and Decreed by the Court that said Anthony Paroni has in his possession belonging to said estate, after deducting his credits to which he is entitled, a balance in cash of \$4,854.14, of which sum, \$791.73 (estimated), consists of a Swiss Bank Account. Three of the heirs of said estate reside in Switzerland. Due to restrictions on withdrawals of funds from foreign countries, said Swiss Bank Account is distributed to the heirs residing in Switzerland, said accounts to be credited to their distributive shares as follows:

To Marie Parone	12/28ths thereof, estimated as	\$339.31
To Mrs. A.P. Fanoli	8/28ths thereof, estimated as	\$226.21
To August Paroni	8/28ths thereof, estimated as	\$226.21

The distributive shares of the heirs of said estate according to the provisions of the last will of decedent in and to the real and personal property and the distributive amounts paid and payable are as set forth in the attached tabulation.

IT IS ORDERED, ADJUDGED, and DECREED that the residue of said estate and all other property belonging to said estate, whether described herein or not, be and the same is distributed as follows:
