BILL OF SALE.

BE IT KNOWN, that we, SUSIE STRICKLAND, a widow, HUGH STRICKLAND and ESSIE STRICKLAND, his wife, all of the County of Eureka, State of Nevada, the parties of the first part, for and in consideration of the sum of Ten Dollars (\$10.00), current lawful money of the United States of America, to them in hand paid by W.J. MAHONEY and JESSIE A. MAHONEY, his wife, both of the County of Eureka, State of Nevada, the parties of the second part, the receipt whereof is hereby acknowledged, and for other valuable considerations, do by these presents grant, bargain, sell, convey, transfer and set over, unto the said parties of the second part, and to their heirs and assigns forever, all those certain chattels and that certain personal property, situate in the County of Eureka, State of Nevada, and particularly described as follows, to-wit:-

69 head of stock cattle of various kinds and ages branded on the left hip with the brand 2U, thus:- 2<sub>U</sub>

7 head of horses of various ages and kinds branded with the said 2U brand, and other brands.

All farming equipment, farming machinery, utensils, power saw and household goods, all situate upon those premises formerly owned by the first parties, situate in the said County of Eureka, State of Nevada.

Also that certain brand an/or branding iron called the 2U brand, made thus:- 2<sub>U</sub> and that certain ear mark made thus:  including all of the rights and privileges incident to the ownership of the said brand, branding irons and earmark.

It is the intention of the parties of the first part to sell to the parties of the second part, all of the livestock formerly owned by the said first parties, and their increase, in connection with the lands and premises sold by said first parties to said second parties, which lands and premises are also situate in the County of Eureka, State of Nevada.
