THIS DEED, made August 19, 1941, by SOUTHERN PACIFIC LAND COMPANY, a Corporation of the State of California, hereinafter called Vender, unto STATE OF NEVADA, hereinafter called Vendee.

WITNESSETH: That Vendor, for and in consideration of Ten and 00/100 (10.00) Dollars, receipt whereof is acknowledged, does hereby grant and convey unto Vendee, its successors and assigns, subject to the conditions hereinafter expressed, a right of way of varying widths for State Highway over, upon and across the following described lands, situated in the County of Eureka, State of Nevada, to-wit:

Parcel No.1: A right of way of varying width over and across a portion of the Northeast Quarter of Northeast Quarter (NEt of NEt) of Section Thirteen (13), Township Thirty-two (32) North, Range Forty-nine (49) East, Mount Diablo Base and Meridian, and Lot Four (4) of Section Seven (7), Township Thirty-two (32) North, Range Fifty (50) East, Mount Diablo Base and Meridian, and being more particularly described by metes and bounds as follows, to-wit:

Parcel No. 2: A right of way two hundred (200) feet in width over and across a portion of the South H lf of Northwest Quarter (SpofNWh), Southwest Quarter of Northeast Quarter (SWhofNEh), and North Half of Southeast Quarter (Nhof SEh) of Section Seventeen (17), Township Thirty-two (32) North, Range Fifty (50) East, Mount Diablo Base and Meridian, being one hundred (100) feet wide on each side of the surveyed highway center line, which center line is more particularly described as follows, to-wit:

Beginning at the point of intersection of said center line at Highway Engineer's Station "C" 518+96.40 P.O.T., with the west boundary of said Section Seventeen (17); said point of beginning being further described as bearing North No Degree, Seven Minutes West (N.O°O7'W.) a distance of One Thousand One Hundred Seventy-three and 35/100 (1173.35) feet from the west quarter corner of said Section Seventeen (17); thence South Seventy-two Degrees, Fifty-one Minutes East (S.72°51'E.) along said center line a distance of Three Thousand One Hundred Sixty-eight and 92/100 (3168.92) feet to a point; thence from a tangent which is the last described course, curving to the right along said center line with a radius of Five Thousand and OO/100 (5000.00) feet, through an angle

Subject to the condition that in the event the said right of way shall be used by the Vendee for any other purpose than for that herein expressly granted, or in the event of non-user by the Vendee of said right of way for a continuous period of two (2) years, then in either of such events the right of way hereby granted, or such part or parts thereof as shall be used for such other purposes or the use of which shall have been discontinued, shall thereupon immediately cease and determine and the right of use and possession thereof and the title thereto shall immediately revert and revest in Vendor, its successors and assigns.

Also subject to any and all easements and rights of way in, upon or across said land.
