Including all water in the so-called "White House Ditch and Dam" with the right of ingress and egress over and across the lands of the first party for the purpose of maintaining said dam and ditch. Provided, however, the first party reserves from this conveyance the right in and to the water and water rights hereinmentioned for the purpose of watering any of his livestock.

There is also included in this conveyance from the first party to the second party all range, ranges and range rights permits now or heretofore had, used or owned by the first party, or his predecessors in interest in connection with all of the lands obtained by first party by conveyance from Norman Biltz and his associates that are North of the Southern Pacific railroad (sometimes called Central Pacific Railway Company) right-of-way as the same now crosses the above described lands.

Provided, however, that the conveyance of the lands above described is subject to all easements and rights-of-way now existing in, upon and across said lands, but not reserving the reversionary interest therein, if any exists, and there is further reserved from the operation of this conveyance and for the use and benefit of the first party, all water rights in connection with the so-called "ROSE DAM AND DITCH RIGHTS" and all other water rights on lands retained by the first party.

TOGETHER with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular the said premises together with the appurtenances unto the said party of the second part and to its successors and assigns forever.
