









BILL OF SALE.

BE IT KNOWN that WE, ANDY PASTORINO and LENA PASTORINO, and HENRY O. PASTORINO, and IRENE PASTORINO, and ANDY R. PASTORINO, JR., of Eureka county, state of Nevada, the parties of the FIRST PART, for and in consideration of the sum of TEN (\$10.00) DOLLARS, current lawful money of the United States of America, to us in hand paid by A. C. FLORIO, of Eureka county, state of Nevada, the party of the SECOND PART, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, and convey unto the said party of the SECOND PART, his executors, administrators, and assigns, certain personal property, described as follows, to-wit: All of the following described personal property, to-wit: 260 head of cattle, yearlings and up, some branded  on left hip, dulap on right side of neck, and ear-marked thus: , and some branded , on left ribs, and double-dulap on brisket, and ear-marked thus: , (Together with all calves under one year old, which are not enumerated in the above number), provided that for each head of cattle, yearlings and up, less than 260 head actually delivered, there shall be deducted from the purchase price, the sum of \$60.00 each. All farming implements of every kind now owned by the parties of the FIRST PART, and all machinery, hay in stack, tools, farming equipment, harness, bridles, saddles, and all livestock of every kind, whether branded or not, and all poultry, and all other personal property of every kind now owned by the parties of the FIRST PART and now upon said ranch, or which is used in connection with the operation of said property as a Ranch plant.

Also all brands, and branding-irons and marks, of every kind, for both horses, and cattle, including the following described brands for horses  on right thigh; horses  on right thigh; cattle  on left hip, and ear-marked thus:  dulap on right side; and cattle;  on left ribs and ear-marked thus: , double-dulap on brisket, together with the exclusive right to use said brands and marks.

SAVE AND EXCEPT, the following described property which is specifically reserved by the parties of the first part from this Bill of Sale. Four saddle horses and one colt, to be selected by the parties of the first part, one washing machine, one radio, one Studebaker Automobile, and the Big Truck, one saddle, one dish-cupboard, all bedding, three bedsteads, and all wedding presents belonging to Henry O. Pastorino, and Irene Pastorino.

TO HAVE AND TO HOLD the same to the said party of the SECOND PART, his executors, administrators, and assigns forever. and WE, do for ourselves, our heirs, executors, and administrators, covenant and agree to and with the said party of the second part, his executors, administrators, and assigns, to warrant and defend the sale of the said property, goods, and chattels hereby made unto the said party of the second part, his executors, administrators, and assigns, against all and every person and persons whomsoever lawfully claiming or to claim the same.
