

REAL AND CHATTEL MORTGAGE

1 This mortgage, made the 15 day of June, 1943, by J.T. Stinnett, of
2 Eureka, Nevada, mortgager, to Fred Minoletti, of Eureka, Nevada, mortgagee,

3 W I T N E S S E T H E

4 That the said mortgager does hereby mortgage to the mortgagee
5 all that real and personal property situate, lying, and being in the
6 town of Eureka, in the county of Eureka, state of Nevada, and which is
7 bounded and described as follows, to wit:

8 REAL PROPERTY

9 Lots 5, 6, and 7, in Block Number 30; and Lots Number 16, 17, 18,
10 19, 20, and 21, in Block number 56, together with all of the im-
11 provements located thereon, as said lots are delineated upon
12 the official map of the town of Eureka, Nevada, county of Eureka,
state of Nevada. together with the tenements, hereditaments,
and appurtenances thereunto belonging or in any wise apper-
taining.

accessories which may be hereafter acquired by the
mortgager.

20 Also all of the machinery, tools, and other personal
21 property of every kind now located in the buildings
22 located upon lots 5, 6, and 7, in Block 30; and Lots 16,
17, 18, 19, 20, and 21, in Block No. 56 of the town of
Eureka, Nevada.

23 Also the freight hauling and trucking business now owned
24 by the said mortgager, and the good will thereof, including
25 all certificates of convenience for transporting freight
26 upon and over the public Highways of the state of Nevada,
27 or any part thereof by the said mortgager, issued by the
state of Nevada, or the Interstate Commerce Commission, or
either or both of them, and especially MG63219 local freight
schedule No. 2, issued October 23, 1939 by Fred Minoletti, as

28 security for the payment to said mortgagee of the sum of Six thousand
29 dollars (\$6,000.00), according to the terms and conditions of a pre-
30 missory note of even date herewith, executed and delivered by the
31 said mortgager to the mortgagee, and also as security for the dis-
32 charge and performance of all obligations and premises by said
mortgager herein contained.

1 Said mortgagor promises to pay said sum of Six Thousand dollars,
2 (\$6,000.00), with interest thereon, at the time and in the manner
3 specified in said promissory note; and also that he will, during
4 the continuance hereof, keep the mortgaged property in good con-
5 dition and repair; And the mortgagee is allowed the right to examine
6 the property at any reasonable time to ascertain whether said pre-
7 property is being maintained in good condition, and may foreclose this
8 mortgage and collect the whole sum due hereon upon failure of the
9 mortgagor to keep said property in good condition, as the same is
10 now, or may hereafter be put into, reasonable wear and tear, and
11 damage by the elements excepted; And that he will keep his head-
12 quarters in the county of Eureka, Nevada, during the continuance of
13 this mortgage, and not remove therefrom any of the property without
14 the written consent of the mortgagee; also that he will, during the
15 continuance hereof, keep each and all of the Trucks insured against
16 loss by fire, theft, or collision in some substantial company in an
17 amount not less than the reasonable value of each and all of said
18 trucks, loss, if any, payable to the mortgagee, as his interest may
19 appear;

20 It is hereby agreed that, if said mortgagor shall fail to make
21 payment of any part of the principal or interest as provided in
22 said promissory note at the time and in the manner therein specified,
23 or if any breach be made of any obligation or promise of the mort-
24 gager herein contained or hereby secured, then the whole principal
25 sum unpaid on said promissory note, with interest accrued thereon,
26 shall immediately become due and payable, at the option of the
27 mortgagee; and he may at once proceed to foreclose this mortgage
28 according to law; or he may, at his option, and he is hereby empowered
29 to do so, enter upon the premises where said mortgages property may
30 be and take possession of any or all of the personal property here-
31 by mortgaged, and remove and sell the same, and dispose of the same,
32 or any part thereof, and, from the proceeds of sale, retain all costs
 and charges incurred by him in the taking and or sale of said

1 property, including any reasonable attorney's fee incurred; also all
2 sums due him on said promissory note under any provision hereof; and
3 any surplus of such proceeds remaining shall be paid to the mortgagor

4 If suit be commenced to foreclose this mortgage, there shall be
5 due from the mortgagor to the plaintiff therein, immediately, on the
6 commencement thereof a reasonable attorney's fee in said action,
7 which said sum or sums is hereby secured.


