Handley, for and in consideration of the sum of Ten Dollars (\$10.00), lawful money of the United States, and other good and valuable considerations, the receipt whereof is hereby acknowledged, hereby grant, bargain, sell, convey and confirm, transfer and set over unto the NEWARK LAND AND LIVESTOCK CO., a partnership composed of Raymond LaBarry and M.B. Bates, all of the said HANDLEY BROS. right, title and interest, claim and demand which they now have or may hereafter acquire in and to the following described personal property, to-wit:

All farming machinery and equipment now situate on either the Circle Ranch situate in White Pine County, State of Nevada, or the Cottonwood Ranch situate in Eureka County, State of Nevada, and specifically, but not inclusive, one (1) 1940 Model Ford truck with a stake body, capacity one ton, one (1) side rake, two (2) stackers, three(3) mowing machines, all ditchers, plows, and cultivators; together with all blacksmith shop tools and all other equipment, including wagons, hay racks, harnesses and saddles; excepting, however, that the said vendors do not agree to sell and the purchasers do not agree to buy the following: one (1) pick-up truck, two (2) saddles, one (1) horse, one (1) bedroom set, one (1) davenport, one (1) rocker, one (1) rug, and the personal effects, bedding, pictures and dishes which the said first parties have expressly designated and pointed out.
