

1 PARTIAL RELEASE OF MORTGAGE

2 KNOW ALL MEN BY THESE PRESENTS: That I, H. G. LATHROP,
3 of the City of Ely, County of White Pine, State of Nevada, the
4 trustee in that certain deed of trust and chattel mortgage given
5 by EUREKA LAND AND STOCK COMPANY, a corporation organized and con-

22 lar, (\$1.00), and other good and valuable considerations and re-
23 ceipt whereof is hereby acknowledged, do hereby release, remise
24 and discharge the personal property hereinafter particularly des-
25 cribed from the lien of said chattel mortgage.

26 Said above mentioned personal property hereby released
27 from said chattel mortgage being more particularly described as
28 follows:

29 2,018 head yearling ewes.

30 This release shall not affect or impair the security of

1 said chattel mortgage upon any of the personal property secured by
2 said mortgage other than the personal property above described.
