-BILL OF SALE-  
 Dated November 25th, 1944.

KNOW ALL MEN BY THESE PRESENTS: That GEORGE W. GOODFELLOW and ELSIE FORREST GOODFELLOW, his wife, of the County of Eureka, State of Nevada, parties of the first part, "Vendors", for and in consideration of the sum of ONE HUNDRED (\$100.00) DOLLARS, lawful money of the United States and other valuable consideration, to them in hand paid by DAN F. RAND and CHARLENE S. RAND, his wife, of the County of Eureka, State of Nevada, parties of the second part, "Vendees", the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, assign, transfer and set over unto said parties of the second part, as joint tenants with right of survivorship, and not as tenants in common and to the survivor of them, and to their assigns, and the heirs, executors, administrators and assigns of the survivor forever, all that certain personal property situate in the County of Eureka, State of Nevada, and more particularly described as follows, to-wit:

All farm implements, tools, machinery and harness and farm equipment of every name, nature, kind and description owned by said Vendors and situate upon the so-called Goodfellow Ranch in Pine Valley, Eureka County, Nevada, the description of which is contained in a deed of even date herewith reserving however to said Vendors all bedding except sufficient for one bed, all rugs, one radio, one clock, two saddles, all personal effects, one picture, all hay, cattle, horses and brands.

Together with all range rights of every name, nature, kind and description owned, used or enjoyed by said Vendors in connection with the premises hereinbefore mentioned.

TO HAVE AND TO HOLD said chattels unto said parties of the second part in joint tenancy with right of survivorship and not as tenants in common and to their assigns, and to the heirs, executors, administrators and assigns of the survivor forever, and the said parties of the first part do for their heirs and assigns covenant and agree to and with said parties of the second part or the survivor or their assigns or the heirs, executors, administrators and assigns of the survivor to warrant and defend the sale of said property, goods and chattels unto the said parties of the second part and their assigns or the heirs, executors, administrators and assigns of the survivor against all and every person or persons whomsoever lawfully claiming or to claim the same.
