WITNESSETH: That Vendor, for and in consideration of Two Hundred Twenty and 00/100 (220.00) Dollars, receipt whereof is acknowledged, does hereby grant and convey unto Vendee, and assigns, subject to the conditions hereinafter expressed, a right of way of varying width for state highway over, upon and across the following described lands, situated in the County of Eureka, State of Nevada, to wit:

Subject to the condition that in the event the said right of way shall be used by the Vendee for any other purpose than for that herein expressly granted, or in the event of non-user by the Vendee of said right of way for a continuous period of two (2) years, then in either of such events the right of way hereby granted, or such part or parts thereof as shall be used for such other purposes or the use of which shall have been discontinued, shall thereupon immediately cease and determine and the right of use and possession thereof and the title thereto shall immediately revert to and revest in Vendor, its successors and assigns.

This conveyance is subject to a right of way of lawful width for any and all lawfull established public roads, and is further subject to all valid and existing contracts, leases, liens or encumbrances or claims of title which may affect the lands herein described and nothing herein contained shall be construed as a covenant equinst the existence of any thereof.

All of the terms, covenants and conditions hereof shall inure to the benefit of and be binding upon the respective personal representatives, successors and assigns of the parties hereto.
