ORDER AUTHORIZING ADMINISTRATRIX TO OPTION MINING PROPERTY

It appearing to the court heretofore, to-wit; on the 10 day of May, 1946, a petition was filed herein by CLORINDA KELLY, as administratrix of the above-entitled estate, praying for an order authorizing her to enter into a lease and option to purchase certain mining property hereinafter described belonging to the said estate; and thereafter, upon due notice, as shown by the proofs on file herein, the said petition came on regularly for hearing upon the 21 day of May, 1946, that thereupon, the allegations of the petition, were duly considered, upon the proofs submitted; and the court being now advised, and it appearing to the court for the best interests of said estate that the prayer of said petition should be granted and that said administratrix should be authorized and entered, and enter into a lease and option to purchase the mining claims hereinafter described, it is hereby,

ORDERED, ADJUDGED, AND DECREED, that CLORINDA KELLEY, as administratrix of the above-entitled estate by and hereby is authorized and directed to enter into a lease and option to sell the mining property hereinafter described upon the terms and conditions set out in the copy of the proposed lease and option which is annexed to the petition herein, and that after said ANGUS MCNAUGHTON, lessee, in said agreement, or his assigns, comply with all of the provisions of said lease and option to purchase, then, and in that event, the said administratrix is hereby authorized and directed to execute and deliver to the said ANGUS MCNAUGHTON, or his assigns a good and sufficient deed of conveyance to each and all of said mining claims together with all of the improvements thereon and the appurtenances. The property and premises affected by this order are particularly described as follows, to-wit: An undivided one-third (1/3) interest in the following described mining claims, to-wit: Commit; Cosmos; Jones & Kyle, Mary Ann; Silver Brick; and Wolverine; lode mining claims, patented, and Wolverine Millsite, patented, together with the appurtenances.
