I, KATHRYN POWERS SADLER, of Reno, Nevada do hereby certify and declare that I am the duly appointed, qualified and acting Administratrix of the Estate of Alfred R. Sadler, also known as Alfred Sadler, deceased; that by deed dated March 12, 1918 and recorded in Book 18 of Deeds at page 289, records of Eureka County, Nevada the Huntington and Diamond Valley Stock and Land Company, a California corporation, conveyed to Edgar Sadler and Alfred Sadler those certain parcels of real property situated in Eureka County, State of Nevada described as follows:

The East half of the Northeast quarter (\mathbb{E}_2^1 of NE₄) of Section Twelve (12); the Northeast quarter (NE₄); the South half (\mathbb{S}_2^1); and the Southwest quarter of the Northwest quarter (\mathbb{S}_2^1) of Section Twenty-three (23); all of Section Twenty-four (24); the North half (\mathbb{N}_2^1); and the North half of the South half (\mathbb{N}_2^1) of Section Twenty-five (25); and the East half of the Northeast quarter (\mathbb{E}_2^1) of Section Twenty-six (26); all in Township Twenty-four (24) North, Range Fifty-two (52) East, Mount Diablo Base and Meridian; also the Southwest quarter of the Southwest quarter (\mathbb{S}_2^1) of Section Seventeen (17); and Southwest quarter (\mathbb{S}_2^1); the West half of the Southeast quarter (\mathbb{S}_2^1) of Section Eighteen (18); the West half (\mathbb{N}_2^1); and the West half of the East half (\mathbb{N}_2^1) of Section Nineteen (19); the Southwest quarter of the Northwest quarter (\mathbb{S}_2^1) of Section Twenty-nine,(29); and the North half (\mathbb{N}_2^1) of Section Thirty (30); all in Township Twenty-four (24) North, Range Fifty-three (53) East, Mount Diablo Base and Meridian; containing approximately Three Thousand One Hundred Twenty (3120) acres, and constituting what is commonly known as the Diamond Valley Ranch.
