

Notice of Intention to Hold Mining Claims

For the Year Ending July 1, 194⁶

LOUIS ROSSI and TONY ROSSI, being first duly sworn, deposes and says: That under and by virtue of the provisions of that certain act of the Congress of the United States, entitled "An Act providing for the suspension of annual assessment work on mining claims held by location in the United States, including the territory of Alaska," approved May 3, 1943, which said Acts suspends annual assessment work on all mining claims in the United States, including the territory of Alaska, until the hour of 12 o'clock Meridian on the 1st day of July after the cessation of hostilities in the present war: PROVIDED, That every claimant of any such mining claim, in order to obtain the benefits of this Act, shall file, or cause to be filed, in the office where the location notice or certificate is recorded, on or before 12 o'clock Meridian of July 1 for each year that this Act remains in effect, a notice of his desire to hold said mining claim under this Act.
