ORDER SETTLING AND APPROVING ACCOUNT, AND
 DECREE OF FINAL DISTRIBUTION

Lloyd G. High, executor of the estate of the above-named decedent, having on the 10 day of September, 1946 rendered and filed herein his final account and report of his administration of said estate which was for a final settlement, and having with said account filed a petition for the final distribution of the estate;

And said account and petition this day coming on regularly to be heard, proof having been made to the satisfaction of the court that the whole value of the estate was less than \$3,000.00, and the court having made its order reducing said estate to a summary administration, and having dispensed with the notice of the hearing of the petition for settlement of said account according to law,

And it appearing that said account and report is true and correct in all respects as rendered, and is supported by proper vouchers; that the sum of \$527.70 was necessarily expended as expenses of administration, and for the payment of the claims allowed against said estate-the said petitioner having advanced the said money from his private funds, he being the sole legatee and devisee under the terms of the will. The vouchers whereof, together with a statement of such expenditures are now presented and filed, and said statement is now settled and allowed, and the payments are approved by this court, and it appearing that all claims and debts against said deceased, and all taxes on said estate, and all debts, expenses, and charges of administration have been fully paid and discharged, and that said estate is ready for distribution, and in condition to be closed.

It is further ordered, adjudged, and Decreed, that the said final accounts of the said executor be, and the same are, settled, allowed, and approved, and that the residue of said estate hereinafter particularly described, and any other property not now known or discovered, which may belong to the said estate, or in which the said estate may have any interest, be, and the same is hereby distributed to Lloyd G. High, your petitioner herein. A full description of said property so distributed is described as follows:

Potato Canyon Spring Water Right No. 7230; N $\frac{1}{2}$ NE $\frac{1}{4}$ of section 32; NW $\frac{1}{4}$ NW $\frac{1}{4}$ of section 33 all in Township 24 N.R., 48 East, containing 120 acres, patented land. Also SW $\frac{1}{4}$ SW $\frac{1}{4}$ section 32, Township 24; SE $\frac{1}{4}$ NW $\frac{1}{4}$ section 3, Lot 4 of section 5 and NE $\frac{1}{4}$ NW $\frac{1}{4}$, and NW $\frac{1}{4}$ NE $\frac{1}{4}$ of section 9, all in Township 23 N.R., 48 East, containing 202.63 acres of patented land.
