

2. By decree of distrubution made on August 14, 1945 by the District Court in the Third Judicial District of the State of Nevada, in and for the County of Eureka, the interest of EVELYN AMELIA TOWNE WORDEN, Deceased, in said property was distrubuted to NELSON TOWNE SHAW (51%), JUNE SHAW HASELTINE (12½%), JULIA A. SHAW (12½%) and to NELSON TOWNE SHAW, ROBERT ALLEN and PAUL A. PFLUEGER (24½%) in trust for the benefit of JUNEVA LANSER.

3. Said lease will expire on June 15, 1948, and the six equal semi-annual installment payments of rent provided in said lease, amounting to \$1,500 each, have been paid.

4. The said lease contains an option to purchase said property for \$75,000, less rent and royalties (now amounting to \$9,000) upon termination of said lease, provided Lessee is not in default, said option to be exercised within the period, in the manner and upon the conditions set forth in said lease.

5. Lessee has requested an extension of the term of said lease and of the time within which to exercise said option, and Lessors are willing to grant the same upon the conditions hereinafter expressed.

NOW, THEREFORE, in consideration of the premises and other valuable considerations to each of the parties hereto moving, the receipt whereof is hereby acknowledged, the parties agree as follows:

(a) Lessors hereby extend the term of said lease and the time within which the said option contained in paragraph 24 of said lease may be exercised until June 15, 1950, upon all of the terms, covenants and conditions set forth in said lease.

(b) Lessee will pay as rent therefor, in addition to the royalties in said lease reserved, the sum of ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500) semi-annually, commencing June 15, 1948, and continuing thereafter semi-annually to and including June 15, 1950, or until the exercise of said option, whichever is first to occur. The payments made hereunder shall be applied and credited on the option purchase price in the event that said option is exercised and as provided in said lease.

(c) This extension is made subject to all of the terms covenants and conditions of said lease, and the rights of the parties hereto and the tenancy of the Lessee and the said option shall be governed by the terms, covenants and conditions of said lease, except as expressly modified by this extension agreement.
