DECREE OF DISTRIBUTION AND
ORDER SETTTLING FINAL ACCOUNT
AND REPORT

Rose Morrison, administratrix of the estate of August Paroni, deceased, having on the 21st day of April, 1948 rendered and filed herein a full account and report of her administration of said estate, which account is for final settlement, and having with her said account filed a petition for distribution of said estate, and said account and petition for distribution coming on regularly for hearing, and proof having been made to the satisfaction of the court that the clerk had given notice of the hearing of said account and petition for distribution in the manner and for the time required by law, and it appearing that notice to creditors has been duly given according to law. It appearing that said account is in all respects true and correct, and that it is supported by proper vouchers and that the residue of said estate in the hands of the administratrix at the time of filing said account and report is the sum of Two Hundred and Two Dollars and Forty-nine Cents, (\$202.49). That all of the claims and expenses of administration and that the sums so paid by the administratrix were necessarily expended in the course of administration of said estate, the vouchers whereof are now filed herein and the said account and report is now settled and allowed and approved. That all of the claims against said estate and the expenses of administration have been fully paid and discharged, and that the estate is now in a condition to be closed and the residue distributed.

IT IS ORDERED, ADJUDGED, AND DECREED, THAT NOTICE TO CREDITORS WAS duly given according to law; that the account and report of the administratrix filed herein be approved, allowed, and settled; that the estate is now in a condition to be distributed; that Giulietta Paroni, Wife of the deceased, Franco Paroni, son of the deceased, and Carla Paroni, daughter of the deceased, all of whom will be of the age of majority at the time of the decree of distribution, are the sole heirs at law, and are entitled to have distributed to them the residue of said estate, and the whole thereof. That the correct name of decedent was August Paroni.

WHEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED that all of the following described property, and any other property not now discovered or which may hereafter be discovered, belonging to said estate, be distributed as follows: To Giulietta Paroni, wife of the deceased, Franco Paroni, son of the deceased, and Carla Paroni, daughter of the deceased, (all of whom will be of the age of majority at the time of the decree of distribution), each, a one-third (1/3) interest of the following described property:

One-eighth (1/8) interest in Pearl Group Mining Claims, (Pearl, Nellie and Tornado Claims) in the Eureka Mining District, County of Eureka, State of Nevada.

Cash in the First National Bank of Nevada, Eureka Branch. \$202.49
