AMENDED DECREE SETTLING FINAL ACCOUNT OF ADMINISTRATRIX AND FINAL DISTRIBUTION

Sue Rand Leavitt, Administratrix of the estate of Mary Booth Rand, deceased, having on the 14th day of June, 1948, rendered and filed herein a full account and report of her administration of said estate, which said account was for a final settlement, and having with said account, filed a petition for the final distribution of said estate, and said account and petition this day coming on regularly to be heard, and proof having been made to the satisfaction of the court that the clerk had given notice of the settlement of said account and the hearing of said petition in the manner and for the time required by law, the court finds:

1. That said account is in all respects true and correct, and that it is supported by proper vouchers; and that there will be no further expenditures necessary in the closing of said estate.

2. That due and legal notice to creditors of said estate has been given in the manner and for the time required by law.

3. That all claims and debts against said decedent and against said estate and all debts, expenses, and charges of administration have been paid and fully discharged and that said estate is ready for distribution and now in a condition to be closed.

4. That the estate was the separate property of said decedent, Mary Booth Rand.

5. That the statutory commissions payable upon the administration of said estate to the administratrix, are hereby waived as indicated by the request in the petition of the administratrix.

6. That under the laws of succession the sons and daughters of deceased are entitled to the whole of said estate thereof, and to any estate or property of the deceased not now known or discovered and that each is to receive a one-fifty (1/5) share of the estate of

the deceased.

IT IS FURTHER ORDERED, adjudged and decreed, that the residue of said estate herein- after particularly described, and any other property not now known or discovered, which belongs to the said estate or which said estate may have an interest in, be, and the same is hereby distributed as follows:

That one-fifth (1/5) of the following described property be distributed equally to the five (5) sons and daughters of the deceased:
