PRELIMINARY AGREEMENT

THIS AGREEMENT, between CHAS. H. AVERY and SAM ZUNINO, of Elko, Nevada, to be known herein as the lessors, and EDW. HEDSTROM, of Oakland, California, to be known herein as the lessee.

The subject of this agreement is the Blackbird Group of claims situated in Frenchy Canyon, Cortez Range of Mountains, Eureka County, Nevada, and about ten miles south of Barth Station on the Southern Pacific Railroad, and about two miles south of the Frenchy Ranch house in Frenchy Canyon.

It is agreed that the sum of FIVE HUNDRED DOLLARS, One Hundred Dollars of which receipt is hereby acknowledged, shall be paid within thirty days.

The royalty for all iron shipped from the property shall be at the rate of seven and one half cents per gross ton $(0.075\cancel{e})$, and shall be applied on any money advanced.

In the event a deed becomes necessary to be issued, a price of FIFTY THOUSAND DOLLARS for the property is agreed upon; however, there shall be no change in the royalty payments with the exception that all payments made are to be credited to the royalty account.

It is further agreed that with the payment of FIVE HUNDRED DOLLARS above referred to, the said lessee shall have a period of seventy-five days from the date of this contract to make what further examinations he cares to make.

It is further agreed that at the end of the seventy-five days a further agreement shall be made covering future payments, but in no event shall the royalty or overall payments be more than specified in this agreement.

In the event that at the end of the seventy-five day period no agreement as to the future status of this agreement is reached, then the whole agreement becomes null and void.

It is further agreed that EDW. HEDSTROM shall have the privilege and will convey to the Pacific States Steel Corporation of Oakland, California, all his right, title and interest in and of this agreement.
