A S S I G N M E N T

CLARENCE T. SADLER, of Berkeley, Alameda County, California, for value received, does hereby transfer, assign and set over unto ETHEL SADLER, of Eureka County, Nevada, as her sole and separate property, all the right, title and interest of Clarence T. Sadler in and to all livestock, farming equipment and other articles of personal property situated on the Diamond Valley Ranch in Eureka County, Nevada.

Clarence T. Sadler, for value received, does further transfer, assign and set over unto said Ethel Sadler, as her sole and separate property, all claims, demands, rights, choses in action, legal and equitable, of every kind and character owned by said Clarence T. Sadler or in which said Clarence T. Sadler has any right, title or interest, arising under and by virtue of that certain Judgment and Decree dated June 19, 1947 and endorsed and filed August 6, 1947 in that certain action in the District Court of the United States for the District of Nevada, entitled: "Clarence T. Sadler, Plaintiff, vs. Edgar A. Sadler, Defendant", Docket No. 371, whereby a trust was declared of the property known as the Diamond Valley Ranch, more particularly described in said Judgment and Decree, and of the appurtenances, livestock, equipment and other personal property upon said ranch, on March 2, 1918, and the increase and proceeds thereof, for the benefit of Clarence T. Sadler, the heirs of Alfred R. Sadler, Deceased, Edgar L. Plummer and Edgar A. Sadler.

Clarence T. Sadler does hereby give and grant unto said Assignee, Ethel Sadler, full right and authority in the place and stead of Clarence T. Sadler and in the name of Clarence T. Sadler, as plaintiff, to manage, conduct, prosecute, maintain, compromise and settle all rights and proceedings remaining undisposed of in said action in the District Court of the United States, for the District of Nevada, hereinabove referred to.
