It further appearing to the satisfaction of the Court that Louisa Sadler died intestate at Grass Valley, California, a resident of Carson City, Ormsby County, Nevada on or about August 6, 1923; that on December 11, 1947, on Petition duly filed by him, Clarence T. Sadler was appointed Administrator of the Estate of Louisa Sadler, Deceased, and having qualified for said trust, since said date has been and now is the duly appointed, qualified and acting Administrator of said Estate; that notice of his appointment as Administrator of said Estate and Notice to Creditors has been posted and published as required by law, the proof thereof being on file herein; that the time for creditors to file claims against the Estate has expired; that the one claim filed against the Estate has been compromised, and said compromise has been approved by order of this Court; and

It further appearing to the satisfaction of the Court that the Estate of Louisa Sadler, Deceased, has been fully administered and is now in a condition finally to be distributed and closed, and that the Account and Report of his administration filed herein on October 2, 1950 by the Administrator is full, true, accurate and complete and correctly sets forth the proceedings had in the administration of the Estate; that all facts stated in / Account and Report are true, and that the relief prayed for by the Administrator should be granted;

- 1. That the First and Final Account and Report of his administration of the Estate of Louisa Sadler, Deceased, filed herein on October 2, 1950 by Clarence T. Sadler, Adminstrator, be, and the same hereby is, settled, allowed, approved and confirmed.
- 2. That the Order for Partial Distribution of the Estate duly given and made herein on September 19, 1949 be, and the same hereby is, ratified and approved.
- 3. That the Administrator be, and he hereby is, authorized and directed to pay the sum of \$5.00 out of the moneys of said Estate to each of the appraisers appointed by order ofthis Court, namely: John Cardinelli, Pete Marialdo, Tom Pastorino, Mildred McNeil, E. W. Miller and William Dial.
- 4. That the Administrator be, and he bereby is authorized and directed to pay to himself out of the moneys of said Estate the sum of \$85 as reimbursement for expenses reasonably and necessarily incurred by him in the administration and management of the Estate.
 - 5. That the Administrator be, and he hereby is, authorized and directed to pay to Spring-

meyer & Thompson out of the moneys of said Estate the sum of \$73.85, as reimbursement for expenses of administration reasonably and necessarily incurred and paid by them in the administration of the Estate.
