ORDER FOR DISTRIBUTION

The final report and petition for distribution and supplement thereto of Frank C. Dunham, as administrator of the estate of said deceased, in propria persona, coming on this 30th day June, 1950, for hearing by the Court, all notices of said hearing having been given as required by law, the Court after hearing the evidence, and finding that the inheritance tax and all personal property taxes due herein have been paid, and that reciprocal rights of inheritance exist between the United States and Canada, orders distribution of said estate as follows:

Is is Ordered, Adjudged and Decreed by the Court that due notice to the creditors of said deceased has been given; that said administrator has in his possession belonging to said estate, waiver of accounting by the only heirs-at-law being filed herein, a balance consisting of the property hereinafter described, at the value of the appraisement: that the sum of \$333.82 is hereby allowed said administrator, as statutory commissions; that said deceased left surviving as his only heir-at-law, Anna C. Drumm, sister; and by virtue of assignment on file herein, the property hereinafter described, and all other property belonging to said estate, whether described herein or not, be and is hereby distributed to Cyril Drumm.
