ASSIGNMENT OF OIL AND GAS LEASES

THAT AGREEMENT Entered into this 9 day of May, 1951, between Homer Black and George H. Hadley, assignors, and Halvern L. Norris, assignee:

WITNESSETH:

The assignors, being the present owners of certain oil and gas leases hereinafter particularly described and referred to, for a valuable consideration in hand paid, and in consideration of moneys heretofore advanced by Halvern L. Norris, assignee, do hereby sell, assign, transfer and set over unto Halvern L. Norris an undivided one-third (1/3) of their interest

in and to those three certain oil and gas leases on lands located in the County of Eureka, State of Nevada, commonly designated as follows:

- (1) Lease on ranch belonging to Henry C. Merrick and wife, and Jerry A. Merrick, consisting of 640 acres of land, more or less;
- (2) Lease on ranch belonging to Mary Bailey consisting of 500 acres of land, more or less;
- (3) Lease on ranch of William R. Rand and wife consisting of 1200 acres of land, more or less;

said leases being recorded in the office of the County Recorder of the County of Eureka, State of Nevada, in Book "F" of Miscellaneous Records, at pages 200, 204, and 209 respectively.

Also granting unto the said Halvern L. Norris the full right to take and receive in kind the full one-third (1/3) share of the said interest in all oils, gas, and other hydrocarbon substances which may be produced, developed on, or extracted and saved from said lands, or in lieu thereof the full right to take and receive a full one-third (1/3) of the said interest in rents, royalties, bonuses, and other moneys which may be received from the production and sale of such substances or which may be received by the lessees upon any sale or subletting of said leases.
