ASSIGNMENT OF LEASE

KNOW ALL MEN BY THESE PRESENTS: That We, IRVIN PUETT and ZELLA FAWN PUETT, his wife, of the Town of Carlin, County of Elko, State of Nevada, for and in consideration of the sum of (\$500.00), Five hundred dollars lawful money of the United States of America to them in hand paid by Wm. F. MATSCHULLAT of the City of Lincoln, State of Nebraska, do by these presents sell, convey, transfer, assign and set over unto the said Wm. F. MATSCHULLAT a portion of a certain Indenture of Lease of gas and oil rights, bearing date of the 21st day of September, 1950, made by WILLIAM R. RAND and ELLA RAND, his wife, of the County of Eureka, State of Nevada, to IRVIN PUETT. That this said assignment applies to the gas and oil rights appurtenant to the following described real property situate, lying and being in the County of Eureka, State of Nevada, and more particularly described as follows:

That this said assignment is for the duration of the lease period recited in the above described indenture and there is specifically hereby reserved unto WILLIAM R. RAND and ELLA RAND, his wife, the rights and royalties as specified in said indenture.

TO HAVE AND TO HOLD the same unto the said Wm. F. MATSCHULLAT, his heirs, executors, administrators and assigns from the date hereof for and during all of the remainder yet to come of the said term of said Indenture of Lease as set forth therein. We do further hereby covenant and agree to and with the said Wm. F. MATSCHULLAT that the said assigned premises and oil and gas rights now are free and clear of and from all former and other gifts, grants, bargains, sales, leases, judgments, executions, back rents, taxes, assessments and encumbrances by us suffered, made or created.

That the assignee herein designated has covenanted to abide by all and singular the terms and agreements on the part of the Lessees to be performed, all pursuant to that said Indenture of Lease as limited to that portion of the oil and gas rights as defined by the real property hereinabove set forth.
