J U D G M E N T

THIS MATTER having come on in accordance with the provisions of Section 14, Subsection (b) (2) of the Nevada Unemployment Compensation Law as amended Stats. 1941, Chap. 185, by way of a Certificate of Judgment filed herein on December 4th, 1951, and it appearing from the record that the defendant, Richard Wilmot and Lowell Thompson, doing business as Phillipsburg Mine--was given notice of more than fifteen (15) days prior to this proceeding, by registered mail, addressed to the last known place of business, as appears more fully from the Affidavit of Rose Welborn--, on file herein, and that said Richard Wilmot and Lowell Thompson, doing business as Phillipsburg Mine was an employer as defined in the Nevada Unemployment Compensation Law, and is indebted to the Employment Security Department of the State of Nevada for contributions to the Nevada Unemployment Compensation Fund, and interest and
