ASSIGNMENT OF OIL AND GAS LEASE

KNOW ALL MEN BY THESE PRESENT: that I, FRANK WORK, of the City of Monterey, County of Monterey, State of California, for and in consideration of the sum of one (\$1.00) Dollar and other valuable considerations do by those presents sell, convey, assign, transfer unto ZIZI WORK, my wife, and JAMES RANDOLPH SPALDING, an undivided interest in that certain agreement and assignment between G. H. HADLEY, Assignor, and FRANK WORK, Assignee, dated October 1, 1951, and filed for record in Eureka County, State of Nevada, on October 4, 1951, at 11:55<sup>th</sup> A.M. in Liber F of Miscellaneous Records at Page 275.

to each 1/48th of a 16/48th undivided interest, or 1/48th to Zizi Work, and 1/48th to James Randolph Spalding.
