DECREE SETTTLING FINAL ACCOUNT OF EXECUTRIX
AND FINAL DISTRIBUTION

Genole Lewis, executrix of the last will and testament of Harry E. Lewis, deceased, having on the 14th day of May, 1953, filed herein a full account and report of her administration of said estate, which said account was for a final settlement, and having with said account filed a petition for the final distribution of said estate, and said account and petition this day coming on regularly to be heard, and proof having been made to the satisfaction of the court that notice of the settlement of said account and the hearing of said petition, in the manner and for the time required by law, the court finds:

1. That said account is in all respects true and correct, and that it is supported by proper vouchers; that the residue of money in the hands of the executrix, at the time of filing said account was \$1000.00.

2. That due and legal notice to creditors of said estate has been given in the manner and for the time required by law.

3. That all claims and debts against said decedent and against said estate, and all personal property taxes due and payable by the estate, and all debts, expenses and charges of administration have been fully paid and discharged, and that said estate is ready for distribution and now in a condition to be closed.

4. That the whole of said estate was the community property of the decedent and your executrix.

5. That the fee to be paid for Johnson W. Lloyd, attorney at law, for services rendered in the administration of such estate should be \$200.00.

6. That under the terms of the last will and testament of Harry E. Lewis, deceased, Genola Lewis, your executrix, and widow of said deceased, is entitled to the whole of said estate after the sum of One (\$1.00) dollar is paid to Vera Lewis, address unknown, and the sum of One (\$1.00) dollar is paid to Leroy Lewis, address unknown.

IT IS THEREFORE ORDERED, ADJUDGED and DECREED that the final account of said executrix be, and the same is hereby, finally settled, allowed and approved.

It is further ordered that the sum of One (\$1.00) dollar be paid to Vera Lewis, address unknown, if and when she can be found.

It is further ordered that the sum of One (\$1.00) dollar be paid to Leroy Lewis, address unknown, if and when he can be found.

It is further ordered, adjudged and decreed that the sum of \$200.00. on account of fees be paid to Johnson W. Lloyd, attorney for executrix, be allowed, authorized and directed to be paid.

It is further ordered, adjudged and decreed that the residue of said estate hereinafter particularly described, and any other property not now known or discovered, which may belong to the said estate or which said estate may have an interest in, be, and the same is hereby, distributed as follows:

The whole thereof to be distributed to Genola Lewis, widow of deceased.

The following is the particular description of the said residue of said estate referred to in this decree and of which distribution is now ordered as aforesaid.
