ORDER AND DECREE SETTLING SECOND
AND FINAL ACCOUNT AND REPORT OF
GUARDIAN

The Second and Final Account and Report of Edward Skillman as Guardian of the person and estate of the above named minor, covering the period between January 1955 and the 15th day of July, 1955, both inclusive, filed herein on July 21, 1955, coming on regularly for hearing on the 4th day of August, 1955 at the hour of 10:00 o'clock A. M. of said day and said Guardian appearing by Robert R. Gill, Esq., his attorney, and no one appearing in opposition thereto.

And it appearing to the satisfaction of the Court that notice of said hearing was given according to law and that the said account is in all respects true and correct as and for the period thereby covered, and that the expenditures therein shown are covered by proper vouchers;

And it further appearing that said Yvonne Skillman heretofore became of legal age under the law of Nevada, that is to say, of the age of eighteen years, and it is therefore proper that the said Guardianship be closed;

And it further appearing that in the interim before authorization was given on the first account for disbursements for support of the said minor, the Guardian expended personal funds totaling \$150.00 for such support, for which he should be reimbursed; that

the suggested allowance to the attorney for said Guardianship of \$100.00 on account of fee for professional services is reasonable; and that he should be reimbursed for his travel expenses from Ely to Eureka and return on this hearing in the suggested sum of \$12.62;

NOW THEREFORE IT IS HEREBY ORDERED ADJUDGED, AND DECREED that the said Second and Final Account and Report of Guardian be, and the same is hereby allowed, settled, and confirmed, and that the said Guardian be and he is hereby authorized and directed to pay to himself the said sum of \$150.00 advanced by him as aforesaid, and to pay to the said Robert R. Gill, as attorney for the said Guardianship the sum of \$100.00 attorney's fee for services rendered and to be rendered in the closing of this Guardianship, together with reimbursement for expenses for attending this hearing in the further sum of \$12.62.

AND IT IS FURTHER HEREBY ORDERED that upon the filing of vouchers herein, showing the distribution to the ward of cash in savings account and in checking account, after such further disbursement for her support as may be necessary, and the payment of such expenses of administration, and of the delivery to the ward of that certain U. S. Savings Bond of maturity value of \$500.00 now held by the Guardian for her, and the recording by him of a certified copy of this Order and Decree as a muniment of title, he be discharged from his trust, and the surety upon his bond be exonerated from all further liability hereunder.
