WITNESSETH: That Grantor for and in consideration of Three Hundred Three and 00/100 (303.00) Dollars, receipt whereof is acknowledged, does hereby grant and convey unto Grantee, its successors and assigns, subject to the conditions hereinafter expressed, an easement and right of way Two Hundred and 00/100(200,00) feet in width for public highway or street, being One Hundred and 00/100 (100.00) feet wide on each side of the center line surveyed for State Route 20-S-602, over, upon and across the following described lands, situated in the County of Eureka, State of Nevada, said center line being more particularly described as follows, to wit:

Beginning at the intersection of said center line (at Highway Engineer's Station "Al"1372+18.65 P.O.T.) with the south line of the Southeast Quarter (SE1) of Section Twenty-one (21), Township Twenty-nine (29) North, Range Fifty-two (52) East, Mount Diablo Base and Meridian, which point of beginning is further described as bearing South Eighty-nine Degrees Fourteen Minutes Fifty-four Seconds West (S.89°14'54"W.) a distance of Two Thousand One Hundred Thirty-five and 26/100 (2135.26) feet from the southeast corner of said Section Twenty-one (21); thence North Four Degrees Twenty-four Minutes Four Seconds West (N.04°24'04"W.) along said center line a distance of Five Thousand Three Hundred Five and 79/100 (5305.79) feet, more or less, to the point of ending at the intersection of said center line (at Highway Engineer's Station "Al"1425+24.44 P.O.T.) with the north line of the Northeast Quarter (NE1) of said Section Twenty-one (21), which point is turther described as bearing West a distance of Two Thousand Five Hundred Fifteen and 95/100 (2515.95) feet from the northeast corner of said Section Twenty-one (21), and being over the West Half of East Half (W20f E2) of said Section Twenty-one (21); Also

Beginning at the intersection of said center line (at Highway Engineer's Station "Al"1266+89.82 P.O.T.) with the south line of the Southeast Quarter (SE\frac{1}{2}) of Section Thirty-three (33), Township Twenty-nine (29) North, Range Fifty-two (52) East, Mount Diablo Base and Meridian, which point of beginning is further described as bearing North eighty-eight Degrees Nine Minutes Nineteen Seconds West (N.88°09'19"W.) a distance of One Thousand Three Hundred Forty-two and 14/100 (1342.14) feet from the southeast corner of said Section Thirty-three (33); thence North Four Degrees Twenty-four Minutes Four Seconds West (N.04*24'04"W.) along said center line a distance of Five Thousand Two Hundred Seventy-four and 65/100 (5274.65) feet, more or less, to the point of ending at the intersection of said center line (at Highway Engineer's Station "Al"1319+64.47 P.O.T.) With the north line of the Northeast Quarter (NE\frac{1}{2}) of said Section Thirty-three (33), which point is further described as bearing North Eighty-nine Degrees Fifteen Minutes Two Seconds West (N.89*15'02"W.), a distance of One Thousand Seven Hundred Forty-four and 53/100 (1744.53) feet from the northeast corner of said Section Thirty-three (33), and being over the West Half of East Half (WgofF\frac{1}{2}) and Southeast Quarter of Southeast Quarter (SE\frac{1}{2}) of said Section Thirty-three (33).

SUBJECT to the condition that in the event the said easement and right of way shall be used by the Grantee for any other purpose than for that herein expressly granted, or in the event of non-use by the Grantee of said right of way and easement for a continuous period of Two (2) years, then in either of such events the easement and right of way hereby granted, or such part or parts thereof as shall be used for such other purposes or the use of which shall nave been discontinued, shall thereupon immediately cease and determine and the right of use and possession thereof and the title thereto shall immediately revert to and revest in Grantor, its successors and assigns; provided, however, that fencing of said easement and right of way by the Grantee so as to enclose less than the entire width herein described shall not constitute or be deemed to be a non-use or abandonment of the unfenced portion of said easement and right of way, if the exterior boundaries thereof for the full width shall be marked by standard State Highway Department monuments.

This conveyance is subject to all contracts, leases, liens, easements and encumbrances or claims of title which may affect the lands herein described and nothing herein contained shall be construed as a covenant against the existnece of any thereof.

All of the terms, covenants and conditions hereof shall inure to the benefit of and be binding upon the successors and assigns of the parties hereto.
